Firestone Building Products Company, LLC, an Indiana limited liability company, warrants that the Firestone ISO 95+ for the above referenced Firestone roofing project will retain 80% of it's published LTTR-Value listed above per the terms and conditions listed below. The insulation shall be evaluated for LTTR-value retainage only one time during the term of this warranty. Owner agrees that the ISO 95+ may not be evaluated more than once during the term of this warranty and that this limited warranty only applies to the results of the one test. Owner agrees to retain original proof of purchase of the ISO 95+ and to supply the original upon making a claim.

Limitations: Firestone Building Products shall not be liable for and this Limited Warranty does not apply to 1.) ISO 95+ that has been damaged, misused, crushed, abused or otherwise improperly installed or applied. 2.) ISO 95+ that is tested for moisture content at the time the samples are taken for LTTR testing has a moisture content of greater than 3% moisture by weight. 3.) ISO 95+ that has been harmed by use of environmental conditions such as cell damage from excessive heat, humidity, or cold. 4.) ISO 95+ that has not been handled, stored, or used according to the instructions outlined in Firestone specifications or literature in affect at the time of the purchase.

Testing Procedures and evaluation: If at any time after the first year of the warranty and prior to the expiration date of the warranty, the owner may have the insulation tested at his expense after notifying and obtaining written approval from Firestone with regard to testing methods and the testing facility proposed for testing. Owner agrees to remove samples, replace and repair the roof system and have tests completed at their expense.

The owner agrees to contact Firestone Building Products in writing 60 days prior to sampling of the materials. Owner agrees that samples will be taken for both testing of the LTTR-Value and moisture content, and will be tested by a NAVLAP certified independent testing lab approved by Firestone Building Products. All testing shall be at the owner's expense. Firestone reserves the right to have additional samples of insulation tested at it's expense at an independent laboratory of Firestone's choice should the samples tested have an LTTR-value of less than 80% of the published LTTR-value at the time of purchase.

Remedy: Should test results determine that the insulation has not retained 80% of it's original published LTTR-value at the time of purchase shown above, Firestone will reimburse the owner a percent of the purchase price of the ISO 95+ on a pro-rated basis or supply replacement insulation at it's discretion. Should a claim be made in years 0 through 2, reimbursement shall be at 100% of the original purchase price with each successive year of the warranty (if applicable) reduced by 10% from the previous year. Only one claim is paid during the term of the warranty.

Transferability: This warranty can be transferred once to a new building owner for a fee of \$200. Subsequent building owner may not transfer this warranty.

NO OTHER PERSON HAS ANY AUTHORITY TO BIND FIRESTONE WITH ANY REPRESENTATION OR WARRANTY WHETHER ORAL OR WRITTEN.
